## **RESOLUTION NO. 16-06**

A RESOLUTION OF THE BOARD OF TRUSTEES OF SPOKANE COUNTY LIBRARY DISTRICT, SPOKANE COUNTY, WASHINGTON, INVOKING THE PROVISION IN THE 2012 CONTRACT WITH THE CITY OF SPOKANE VALLEY FOR THE CITY TO REPURCHASE PROPERTY OWNED BY THE LIBRARY DISTRICT.

## SPOKANE COUNTY LIBRARY DISTRICT Spokane County, Washington

BE IT RESOLVED BY THE BOARD OF TRUSTEES OF SPOKANE COUNTY LIBRARY DISTRICT, SPOKANE COUNTY, WASHINGTON, as follows:

WHEREAS, the Spokane County Library District, Spokane County, Washington (the "District"), is a rural library district duly organized and existing under and by virtue of the Constitution and the laws of the state of Washington (the "State");

WHEREAS, the District provides library services to residents of the unincorporated portions of Spokane County, Washington, (the "County"), as well as residents of several cities within the boundaries of Spokane County including the City of Spokane Valley ("Spokane Valley") and

WHEREAS, the District entered into an agreement in 2012 with Spokane Valley to purchase land on Sprague Avenue for the purpose of building a new library adjacent to a future City park and

WHEREAS, the District placed a ballot issue before the voters to form the Spokane Valley Library Capital Facilities Area (SVLCFA) in 2014 and

WHEREAS, in the April 2014 Special Election, voters approved Proposition 1 to form the SVLCFA receiving 59.22% approval and

WHEREAS, in the April 2014 Special Election 54.81% of voters were in favor of the bond funding request to build new libraries, and failed to reach the required super majority of 60% and

WHEREAS, the District placed a second ballot measure before the voters in the August 2015 Special Election receiving 57.57% approval and failing to reach the required super majority of 60% and

WHEREAS, the SVLCFA was subsequently dissolved after the second failed ballot measure as per state law and

WHEREAS, the District has responded to the voice of the voters by preparing a plan to expand the existing Spokane Valley Library and

WHEREAS, The Spokane County Library Board of Directors has adopted Resolution 16-05, declaring that the District will not put a ballot measure for construction of library facilities on the property located at the corner of Sprague Avenue and Herald Road before 2018; and

WHEREAS, the 2012 Interlocal Agreement with Spokane Valley provides that the City will repurchase the property from the Library District at the same price paid by the Library District to the City, in the event that the District is unable to secure voter approval of a construction bond for the library building; and

NOW, THEREFORE, IT IS HEREBY FOUND, DETERMINED AND ORDERED, as follows:

**Section 1:** The Spokane County Library District invokes Section 10 of its 2012 Agreement with the City of Spokane Valley, wherein the City agreed to repurchase the property at the corner of Sprague Avenue and Herald Road, Spokane Valley, Washington (Parcel 45174.9063), at the price paid to the City in the amount of \$841,414.

**Section 2:** Upon payment in full of the amount specified above, the Interlocal Agreement is terminated.

**Section 3:** This Resolution shall take effect immediately upon its adoption.
