A RESOLUTION OF THE BOARD OF TRUSTEES OF SPOKANE COUNTY LIBRARY DISTRICT, SPOKANE COUNTY, WASHINGTON, REVISING THE DISTRICT'S FINAL 2011 BUDGET, ADOPTED ON DECEMBER 21, 2010, WITH RESOLUTION NO. 10-13; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO.

BE IT RESOLVED BY THE BOARD OF TRUSTEES OF SPOKANE COUNTY LIBRARY DISTRICT, SPOKANE COUNTY, WASHINGTON, as follows:

WHEREAS, Spokane County Library District, Spokane County, Washington (the "District") is a rural county library district duly organized and existing under and by virtue of the Constitution and the laws of the State of Washington;

WHEREAS, RCW 27.12.210(5) provides the Board of Trustees (the "Board") with exclusive control of the finances of the District;

WHEREAS, the Board adopted a Final 2011 Budget (the "Budget") with Resolution No. 10-13 on December 21, 2010;

WHEREAS, the Budget's Capital Projects Fund included no expenses for 2011;

WHEREAS, on March 15, 2011, the Board approved the purchase of real property located at 9220 E. Upriver Drive, Spokane, to allow for future expansion of the adjacent Argonne Library/Administrative Offices building;

WHEREAS, the Board has determined it is necessary to revise the District's 2011 Capital Projects Fund budget to provide authority for this purchase and related costs;

NOW THEREFORE, IT IS HEREBY FOUND, DETERMINED AND ORDERED as follows:

Section 1: ADOPTION OF REVISED 2011 CAPITAL PROJECTS FUND BUDGET

The Board hereby adopts a Revised 2011 Capital Projects Fund Budget, (a copy of which is attached hereto as Exhibit A and incorporated herein by reference), as follows.

Capital Projects Fund (008-661): \$200,000.

Section 2: EFFECTIVE DATE

This resolution shall be effective immediately upon its adoption and approval.
